

AEGIS thematic conference Basel, 7 – 9 October 2010

As member of AEGIS, the European Network of Excellence in African Studies, the Centre for African Studies Basel holds a conference on its joint research theme, urbanisation in Africa. The meeting focuses on intervention and invention in African cities. In this context and as a pre-programme of the conference the Commission for Research Partnerships with Developing Countries (KFPE) holds its annual meeting, in which case studies of the translation of research in urban development will be presented.

We live in a rapidly urbanizing world. For the first time in human history, more than half of the world's population lives in cities. We only begin to understand the consequences this upcoming urban age will have, and how the urban experience will shape societies around the globe. Until now, research on cities worldwide is still centred on cities in Europe and the United States which are seen as the standard model. However, cities in the global South are undergoing a much more rapid transformation, and many interlinked transitions, whereby Africa features the highest urbanization rates worldwide. Cities are almost always major destinations of migration, and African cities serve as the main hub for migration towards Europe. A better understanding of these processes is urgently needed in view of the enormous threats such as global climate change and associated natural and man-made disasters. This is because their impact is particularly high in cities due to the density of population and infrastructure and the concentration of financial, economic and technological resources.

Rapid growth at a time of major transitions and transformations presents challenges as well as opportunities. Scholars call for a new approach to urban studies which examines cities from a more global, comparative perspective. This new approach should also pay more attention to the role societal creativity plays in processes of urbanization instead of concentrating exclusively on expert driven planning and intervention. Especially in fast growing cities with weaker institutional capacity for interventions, the interplay between intervention and invention, between expert and societal agency not only becomes more tangible but also more crucial. Processes of innovation and transformation touch on all spheres of life, and they will become even more significant in the cities of the future around the world. Transformations, interventions and especially innovations converge in cities because cities produce difference – differences between rich and poor, safe and unsafe, healthy and unhealthy and in many other domains. The conference therefore addresses the general question, how cities in Africa, being among the most dynamic and least regulated cities in the world, produce difference?

- What potential can be created at the interface of intervention and invention for the cities of the future?
- What can we learn from the fast-growing and often institutionally weak African cities?
- How can this new understanding inform policies and interventions which work with and not against the inventive potential of urban dwellers?
